## CONDITIONS

The West of England WSA reserves the right to cancel courses if student numbers are below the minimum of 8 students, however, we try to run courses if we possibly can. In the rare event of a course being cancelled, we will arrange to transfer students to another course if possible. If we cannot do this, the full fee is refunded immediately.

## Cancellation Terms

Should a candidate have to cancel at short notice, our cancellation terms are:

Up to 28 days before start of course 100% refund

Up to 14 days before start of course 50% refund

Up to 7 days before start of course 25% refund

Cancellations within 7 days are not refunded. However, in the case of last minute cancellations, we will endeavour to transfer a student to another of our courses if possible.
